

Single Mother Families Australia (SMFA) was conceived in 1973 as a lead national voice with policy insight and expertise. We commenced life as the National Council of Single Mothers & their Children Inc.

SMFA is an organisation dedicated to single mother families.

Ambition

SMFA works to reframe the dialogue and ensure that single mothers' strengths, their voices, and their lived reality are central to policy determinations. The ambition is undertaken knowing that single mothers are disproportionally harmed by entrenched financial distress, poverty, and gendered violence. Moreover, single mothers encounter systems and assumptions that have unconscious and conscious biases, too often steeped in prejudice whilst ignoring the gendered dynamic.

SMFA also provides a 'soft entry ~ light-touch' online platform through a public Facebook page. Creating a safe and affordable online community for single mothers. The Facebook page disseminates information and responds to single mothers' requests.

One of our greatest strengths is our expertise and commitment to working with and for the advancement of single-mother families harmed by poverty, hardship, and gendered violence.

Single Mother Families Australia (SMFA) was instrumental in many of the gains highlighted in our report. The panel reflected on Whitlam's 50 years of the Supporting Mothers Benefit (1973), as authored in the chapter Out of Wedlock Out of Luck' from Women and Whitlam: Revising the Revolution Book.

SMFA would like to thank the Paul Ramsey Foundation, which provided a donation enabling women who live in poverty, who are at risk or who are homeless to attend and be part of the critical debates and delegations in Parliament House. Key events were held on the 22nd and 29th March 2023. Importantly, single mothers had full and direct engagement and could speak to the rules and laws that influence, diminish, or shape their lives. We thank the resolve of Toni Wren, who leads the Antipoverty Week and Economic Security 4 Women, as it takes many voices to become a chorus for change.

SMFA is hopeful that contractual arrangements with the Government can be reflective of providing a voice for single mothers; it is cognisant of our established policy expertise and recognises the many roles and requests initiated by the Government. The Finance Statement is on page 8; our finances are Independently Audited by PCS Accountants & Business Advisors and prepared by our industrious bookkeeper, Jen Taylor. We trust that you will share the amazement of what was achieved with such small resources.

Parenting Payment Single



1973, The Supporting Mothers Benefit gave single mothers economic justice and dramatically interrupted the practice of forced adoption.

2023, the Parenting Payment Single Australia was enhanced. Increasing access for families whose youngest child is 14 years from 8 years.

70,000+ families regained access to the Parenting Payment Single on 20 Sept 23.

A full understanding of this intergenerational investment is still to unfold.
